Dear Ms Faehrmann and Mr Field

I write to you once more in relation to deceptive conduct. Sadly, such deceptive conduct relates to the ill-mannered behaviour of the NSW Greens.

On arriving home last evening, I found a yellow C4 envelope in my letterbox. Such C4 envelope contained my application to be enlisted as a NSW Justice of the Peace, as firstly provided to Jenny Leong.

However, on inspection, I noticed that the said envelope was unfranked and only had a one dollar stamp on it. If such envelope had been sent via Australia Post, it would have been franked and would have required stamps to the value of \$2.00 in order to be posted.
